February 2013

Our next meeting is scheduled for February 12th at 11:30 a.m. and will be held at Michaels in Mountain View. USAIG is our sponsor and they will bring with them three expert speakers who will talk to us about the very real problem of Runway Excursions. The focus of the meeting will be "Runway Excursions...Make it Stop!!!". USAIG and the NBAA have worked together to develop a Runway Excursion safety forum that will require us to extend our meeting with an optional two-hour breakout session that will go into more detail on runway excursions and how to prevent these events by proper technique and planning. This valuable presentation has been accredited by the NBAA for a continuing education credit towards Certified Aviation Manager (CAM) certification.

The focus is on mitigating the risks and reducing the occurrence of runway excursions. The session leverages the benefits of pilots talking with pilots: the presenters bring a mix of military and civilian flying backgrounds, and include current operational corporate and airline pilots.

We are expecting another large crowd, as this is a valuable presentation for every pilot and manager.

IS-BAO Workshops

Given the high demand for IS-BAO knowledge in this area, we wanted to help IBAC with their IS-BAO Fundamentals and Auditor Accreditation workshops. This is real training for the Fundamentals workshop, your department's Safety Officer would really benefit from this training (I know I did). The Auditor Accreditation workshop is exactly what it implies. This is how you become an IS-BAO Auditor. This workshop will also count as renewal training for existing IS-BAO auditors.
